3. The Grantee shall furnish to the Foundation written narrative reports on the program aspects of the grant and financial reports on the expenditure of funds. The nature and timing of the reports are described in Appendix A to this letter.

4. The Grantee will refund to the Foundation any amount of the grant which is not expended for the purposes described in the Grant Summary.

5. The Grantee confirms that there have been no substantial changes in the character, purposes, methods of operation, and sources of support of the organization since receipt of its determination letters from the Internal Revenue Service, copies of which were previously provided to the Foundation, and that no change is planned.

Please indicate your acceptance of the conditions governing this grant by signing the enclosed copy of this letter and returning it to us. After we have received the signed letter, and the Foundation is satisfied that the grant will comply with the requirements of the Internal Revenue Code of 1954, as amended, so as not to require expenditure responsibility, a check can be issued to your organization.


