Dear Megan,

I don't know if Mark Hogan is back yet, in light of his loss, so I am writing directly to you with copies to Mark and Catherine Callagy. Additionally, yours is the only email address I know I have correctly.

I think you know I have been dealing with Mark and with Dr. Bill Cook, who have both been wonderful, to set up a fund to honor the memory of my nephew. I have been doing this on behalf of my nephew's older brother Christopher Reddy. The memorial service is this Friday, and as invitations have been going out, you may start to receive gifts immediately so I am getting this information to you all. Unfortunately, it is taking longer than I would have thought to get the details nailed down, so we are doing this a bit backwards (meaning gifts will be coming in before I have a confirmation from St. Vincent's that everything is in place. But that's the way it went.

Here is what we have agreed upon:

The fund is to be The Devin Thomas Reddy Fellowship Fund

It is in Devin's memory and dedicated to the work of Dr. William Cook, Coordinator for the Fellowship Program in Oncology at the Cancer Care Center of Saint Vincent's Hospital. Devin was close to Dr. Cook and it was his wish that something of this nature be created. Dr. Cook has been personally involved in creating the purpose of the fund. The Fund will support the costs associated with the Oncology Fellows' attendance at required off-site trainings as Dr. Cook deems appropriate. St. Vincent's Foundation has agreed to manage the fund, preserving the corpus, and making the interest earnings available for the

purpose for which the fund has been established.

Finally, as you may know, we are still working on a naming opportunity at the Cancer Care Center. The administrator is open to this, and is working on a concept with Dr. Cook. At this point, the notion of a plaque on the Fellows Office (the original suggestion) has not been accepted for several reasons that make sense. But I am confident that with Dr. Cook's intervention, a permanent remembrance will be realized.

Please let me know as soon as is possible that you have received this email and have made sure Mark and or Catherine Callaghy have seen it. I await confirmation that of this has been done correctly.
